					It should be noted that the current use of "dual-class stock" or "weighted voting rights" (WVR) by publicly-listed companies transforms the notion of "ownership". In modern economics, many companies (See Reference #1) issue shares in two categories: "class A" shares give one vote per share while shareholders have multiple votes for each "class B" share (See Reference #2). This allows founders of a company to diversify their wealth and generate equity finance without losing control who retains their role on decision-making by holding minority of the equity (See Reference #3). In other words, owners of "class B" shares have greater voting powers than their economic interests. Therefore, to retain control on companies, it is not required to have majority of shares. "Class B" shares allow to maintain the control of founders on companies with even minor shares. Already industries such as technology have favored and some stock exchanges (New York, Singapore, Hon Kong - (See Reference #4)) allows for dual-class shares (See Reference #5). For example, founder of Facebook – Mark Zuckerberg owns 70% of voting rights with only 18% "class B" shares (See Reference #6). In Facebook case, per "class B" share have 10 votes while each "class A" share have only one vote. Regarding protection of investors' rights, transparency and the credibility of information by dual-class companies, studies confirm that these companies do provide credible information to their investors (See Reference #7) with the aim of reducing their lack of diversification costs while retaining control (See Reference #8).
